The Earned Income Tax Credit belongs to you. Apply now!

Make sure you get the most from your paycheck. You may qualify for the Earned Income Tax Credit (EITC). But to get EITC, you must file a 2007 tax return and fill out a special EITC form.

### Money for your family!

The Earned Income Tax Credit is a tax credit for working families. Do you expect your adjusted gross income (AGI) will each be **less than**: \$33,241 (\$35,241 if married filing jointly) expect to have 1 qualifying child; \$37,783 (\$39,783 if married filing jointly) expect to have 2 or more qualifying children.

**A Qualifying Child is:** Son, daughter, stepchild, eligible foster child, brother, sister, half brother, half sister, stepbrother, stepsister, or a descendant of any of them (for example, your grandchild, niece, or nephew). An adopted child lawfully placed with you for legal adoption. Foster child placed with you by an authorized placement agency or judgment, decree, or other order of any court.

### It's FREE

An IRS-certified trained volunteer will prepare and e-file to help you get all of your tax credits and refunds for free. You can get the tax credits you earned and not have to pay a tax preparer.
